


## NOTICE OF PUBLIC HEARING AND MEETING OF THE IRION COUNTY WATER CONSERVATION DISTRICT (ICWCD)

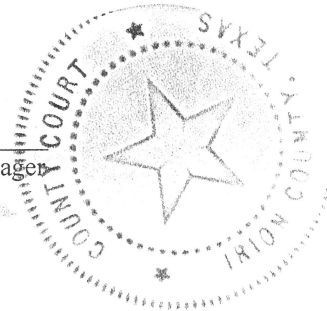
