A PUBLIC MEETING will convene at 6:00 PM on the 14th day of SEPTEMBER, 2026, in the Irion County Courthouse, Commissioners Courtroom, 209 N Park View, Mertzon, Texas. The purpose of this meeting is to accept public comment on the proposed FY 2026-27 Budget and proposed 2026 Tax Rate. The proposed 2026 Tax Rate is \$0.010683 per \$100 of valuation. The proposed tax rate is 9.7% **below** the no-new-revenue tax rate and will **not** increase taxes.
